WAIT LIST FOR WITHDRAWN ENTRIES

After the closing date, FKC is offering a Wait List to fill openings created by withdrawn entries after closing. A maximum of 20 entries will be placed on the wait list. All entries including wait listed entries must be received by the Trial Secretary prior to Friday, October 18, 2024 6:00 p.m. Any entries withdrawn prior to October 27, 2024 at 6 PM, will be replaced by a wait list entry when available, a full refund will be given to withdrawn entries when wait listed entries are available to replace the pulled entry. Any wait list entry that does not move off the wait list into the trial by October 27, 2024, 6 PM will receive a full refund. If a dog is pulled but cannot be replaced, the exhibitor will not receive a refund and the dog will be considered absent for the trials. There are wait listed dogs on Saturday and Sunday.

MOVE-UPS

It is the option of the club to allow day-to-day move-ups. Exhibitors should refer to a club's premium list to verify the club's policy for moving a dog up. If offered, dogs shall be moved up to a higher class at the request of the owner, as a result of the dog qualifying for an agility title.

Move-ups prior to a set of trials: Dogs shall be moved up to a higher class at the request of the owner, as a result of qualifying for an AKC agility title, provided that the request is made in writing to the Trial Secretary not later than 6:00 p.m. on the Monday preceding the set of trials for trials starting on a Thursday-Sunday. The request for moving up must be made in writing at the trial site to the Trial Secretary no later than the day preceding the event. Regulations for Agility Trials, Chapter 1, Section 20, (Amended September 1, 2011.)

A dog which has been entered in a Novice "A" class for which it is not eligible to be entered in due to class restrictions on the dog or handler may be moved to the Novice "B" class under the following conditions: The request for the move must be in writing and presented to the superintendent or the trial secretary at least 30 minutes prior to the start of each trial." Dogs moved up will run at the end of the running order.

ROUTES TO THE TRIAL

FROM THE NORTH and SOUTH: I-25 to Colorado Hwy 119 (Exit 240). Proceed west on Hwy 119, approximately 7.5 miles. Turn right on Nelson Rd. Go approximately 4/10 mile to first fairgrounds entry on right, into the fairgrounds. There are parking lots located on the east side of the Arena Building, north side of the fairgrounds, and to the southwest of the arena building.

REGARDING THE TRIAL and AKC MEASUREMENTS...

This Trial is held under American Kennel Club Rules and Regulations.

Effective January 1, 2010, exhibitors are no longer required to provide proof to Trial Secretaries that their dog has a valid jump height card as part of the check-in process. Dogs without a valid Jump Height Card/Form may still compete; but they must be measured/wicketed by the **Judge of Record** PRIOR to running in their class and this measurement will be valid for that weekend of trials only. However, if a **Volunteer Measuring Official (VMO)** or an **Agility Field Rep** is present; **ALL** dogs without a valid Jump Height Card/Form must be measured at some time during the trial or cluster of trials. This does not preclude having the dog wicketed by the Judge of Record if the VMO or Rep is not available to measure the dog **before** its first run of the trial or cluster of trials. It is the exhibitor's responsibility to have their dog measured prior to running and failure to do so will result in the cancellation of any qualifying scores.

All exhibitors must check in before judging of your first class on the first day you are entered. VMOs will be available for measurement
