#### **BUILDING AVAILABILITY & CRATING**

There is crating in the Arena for exhibitors. Mats used under crates must match the dimensions of the crate. Excess matting will not be allowed. Please be prepared to stack crates. Ring set up will begin at noon on Friday, December 20, 2024. Crating will be available after the ring is set, for those who come to help the club set up. Other exhibitors will be allowed to set up Saturday & Sunday during trial hours. The building will open at 7:00 AM each day. Trial hours are 7:00 AM – 30 minutes after the conclusion of judging for all trial days.

## **MOVE UPS**

It is the option of the club to allow day-to-day move-ups. From Chapter 1, Section 20: Move-Up entries will be accepted for dogs that have completed a title after the closing date. Email notification of move up or class change is acceptable, with return receipt verification from the secretary. Either Move Up forms or emails must be completed and delivered to the Trial Secretary prior to 6 PM on the Monday evening preceding the event. Move-up entries for Saturday or Sunday must be delivered to the Trial Secretary within 30 minutes of the conclusion of judging of the class they are moving up from. Dogs so moved up will run at the end of the running order. Move-ups can only be accepted if judging limits are not exceeded. Entry move-up valid only if the dog was already entered in the Event indicated and only if approved by the Trial Secretary. Dogs moved up will run at the end of the class running order.

#### **ROUTES TO THE TRIAL**

**FROM THE NORTH and SOUTH:** I-25 to Colorado Hwy 119 (Exit 240). Proceed west on Hwy 119, approximately 7.5 miles. Turn right on Nelson Rd. Go approximately 4/10 mile to first fairgrounds entry on right, into the fairgrounds.

# AFTER CLOSING WAIT LIST

After the closing date, GDACSC is offering a Wait List to fill openings created by withdrawn entries after closing. A maximum of 20 entries will be placed on the wait list. All entries including wait listed entries must be received by the Trial Secretary prior to Wednesday, December 4, 2024 6:00 p.m. Any entries withdrawn prior to December 15, 2024 at 5 PM, will be replaced by a wait list entry when available, a full refund will be given to withdrawn entries when wait listed entries are available to replace the pulled entry. Any wait list entry that does not move off the wait list into the trial by December 15, 2024, 5 PM will receive a full refund. If a dog is pulled but cannot be replaced, the exhibitor will not receive a refund and the dog will be considered absent for the trials. There are wait listed dogs for this trial.
