BUILDING AVAILABILITY & CRATING

Douglas County Fairgrounds, Indoor Arena, 500 Fairgrounds Dr, Castle Rock CO
80104 This trial will be held indoors, in two dirt rings.
Ring Measurements Standard Ring 100' x 100' & 100' x 90' Jumpers Ring

NO DOGS MAY BE LEFT IN THE BUILDING OVERNIGHT

Trial site hours: 7:00 a.m. – 30 min. following the conclusion of judging, daily. Judging to begin 8:00 a.m. each day

DO NOT ALLOW DOGS TO URINATE ON THE BUILDING OR TRASH CANS.

Specific, well indicated containers will be provided for solid dog waste, please use these containers and refrain from putting dog waste in regular or recycle trash cans.

Setup will start at 3:00, Thursday afternoon, and we do welcome your help! Those helping with set up may place a mat upon arrival. Crates may be set up once the site is set up and the all clear is given. General crating will be available during trial hours.

PARKING!! IMPORTANT!! On the south-ish end of the building, (the side where RVs are parked), cones will be placed to mark the parking for the rows closest to the building. **DO NOT PARK OUTSIDE OF THE CONES.** LARGE fire engines and other rescue equipment **MUST** be able to easily access the building and pull through. This close in parking area will be more limited than it has been in the past. The pull through area may be still be used for loading and unloading. Castle Rock Fire Department is working harder to ensure our safety and may be stopping by to ensure we are operating with a safe site plan. While there will be less close in parking there **IS** ample parking available, just a bit further! Thirty feet of clearance from ALL parts of the building to vehicles is **REQUIRED.** MHGRC thanks everyone for cooperating on this important safety aspect.

IMPORTANT!! While the respiratory illness seems to be on the decline precautions and good dog management/manners are always good practice!

PLEASE:

1. Not all dogs want to say "Hello!" Keep your dogs on a short leash. Do not allow your dogs to visit with dogs outside of your/their family without owner consent. Keep your dogs behind you going in and out of doors.
2. Keep your dogs noses away from other dog's crates. If your dog is reactive while crated please cover the front of the crate.
3. Do not leave bowls out side of your crate on the ground for others to sniff/lick.
4. IF YOUR DOG IS ILL OR A DOG IN YOUR FAMILY IS ILL, PLEASE STAY HOME.

Indoor crating space is not guaranteed. Please be prepared to stack crates. Crating areas will be provided on the arena floor. No crating allowed in bleachers, bleacher area, or walkways. No chairs will be allowed in the crating areas. There is ample bleacher seating available. Please park in designated lots, and move from the unloading area promptly after unloading.

CONFLICTS

If you anticipate a conflict in ANY class, you MUST mark your name with a "C". If you have a conflict, PLEASE move within in your height if possible. If you do have a conflict with your run time that cannot be accommodated by moving within your height, if possible, you should walk/run in an earlier jump height, which allows the score table to close out classes. You must have permission from the Gate Steward or Judge to move a dog to ANOTHER jump height. If your conflict is only with your walkthrough, PLEASE try to walk with an earlier group, so PLEASE plan ahead and please be kind to your fellow volunteers! **Don't panic, as long as the course is still available, we will work to get your runs in if you have marked your dog as a conflict.**

REGARDING AKC MEASUREMENTS and CHECKING IN and MAPS...

All exhibitors must check in before judging of your first class on each day you are entered. All dogs competing in agility must have a valid AKCOfficial Jump Height Card or form. There will be VMOs present at this trial.

ROUTES TO THE TRIAL

Just a few minutes South of Denver and easily accessible from I-25. Exit I-25 at Castle Rock exit 181 (Plum Creek Parkway – turn east). Follow Plum Creek Parkway (approximately 1 mile), turn left (North) at Fairgrounds Drive, and follow road North to indoor events center located to the West of the main building. Use Gate E to enter area. Parking will be on East and West ends of the building.

RV PARKING

ALL RVs MUST be pre-registered and paid in advance, including dry camping and day parking. RVs without reservations will be required to park outside the fence in Lot #1. RVs with reservations will receive confirmation information prior to the event. Spots are assigned on a first come basis and are not confirmed until reservation form and payment are received. DO NOT CONTACT THE FAIRGROUNDS FOR INFORMATION OR RESERVATIONS! Cost \$15 per NIGHT with 30 AMP electric (same charge for day parking with electric). Reservations MUST be canceled by the closing date of the trial to receive a refund.

No fee for dry camping-reservations and EXHAUST DIVERTERS REQUIRED due to a high fire danger in the area.

Please note that RV parking is a privilege. ALL RV'ers are responsible for any damage done to the facility. Failure to act courteously, responsibly and follow all rules will result in loss of that privilege and may result in a bench committee.

Parking will be allowed after 3pm, April 4, 2024. NO EARLIER HOOK UPS!!!

MOVE UPS

It is the option of the club to allow day-to-day move-ups. Exhibitors should refer to a club's premium list to verify the club's policy for moving a dog up. If offered, dogs shall be moved up to a higher class at the request of the owner, as a result of the dog qualifying for an agility title.

From Chapter 1, Section 20: Move-Up entries will be accepted for dogs that have completed a title after the closing date. Email notification of move up or class change is acceptable, with return receipt verification from the secretary. Either Move Up forms or emails must be completed and delivered to the Trial Secretary prior to 6 PM on the Monday evening preceding the event. Move-up entries for Saturday or Sunday must be delivered to the Trial Secretary within 30 minutes of the conclusion of judging of the class they are moving up from. Dogs so moved up will run at the end of the running order. Move-ups can only be accepted if judging limits are not exceeded.

Entry move-up valid only if the dog was already entered in the Event indicated and only if approved by the Trial Secretary. Dogs moved up will run at the end of the class running order.

There are no wait listed entries, so no after closing date pulls are available.

REGARDING THE TRIAL and AKC MEASUREMENTS...

All exhibitors must check in before judging of your first class on the first day you are entered. All dogs competing in agility must have a valid AKC Official Jump Height Card or form. If the dog does not have a valid Jump Height Card or form it must be measured by a VMO, AKC Field Representative or by the judge(s) of record before it runs. There will be VMOs present at this trial.
