## IMPORTANT TRIAL INFORMATION

Adequate crating space is available. Be prepared to stack crates. The club reserves the right to rearrange crating space to accommodate all exhibitors. Seating in the crating area may be restricted to allow all exhibitors adequate space for crates. Dogs may not be left in the building over night. Crates may be left over night. The building will be locked, but any items left in the building are left at your own risk.

Obedience and Rally Class Transfers will be accepted as space permits, in accordance with Chapter 1, Section 16a & b of the Obedience Regulations. Requests for class transfers must be made in writing and presented to the trial secretary at least 30 minutes before the start of each trial. Obedience jump heights will be organized by jump height. Running Order in classes involving jumping exercises will be small to tall each day.

Classes listed as "after noon" will run in the order shown and will not start prior to 12:00 noon.

All Rally classes will have a walk through prior to the start of judging for that level. Rally classes/levels that are scheduled to run over 2 hours will have an additional walk-through of 10 minutes after the first 2 hours of judging.

In the Novice A & Beginner Novice (A & B) Obedience classes, a walk-through prior to the start of the class, will be allowed for handlers without their dogs. The judge will be available in the ring during this period to brief the handlers and answer any questions they might have.
