MOVE UPS AND CLASS CHANGES

From Chapter 1, Section 20: Move-Up entries will be accepted for dogs that have completed a title after the closing date. Email notification of move up or class change is acceptable, with return receipt verification from the secretary. Either Move Up forms or emails must be completed and delivered to the Trial Secretary prior to 6 PM on the Monday evening preceding the event. Move-up entries for Saturday or Sunday must be delivered to the Trial Secretary within 30 minutes of the conclusion of judging of the class they are moving up from. Dogs so moved up will run at the end of the running order.

Directions to Animal Hospital from the Trial Grounds:

Orchard Mesa Veterinary: Start out going NORTH on FAIRGROUNDS ENTRANCE toward US-50 W. Turn LEFT onto US-50 W. End at 2668 Highway 50 Grand Junction, CO 81503-1964 (1.3 miles)

Grand Valley Veterinary Emergency Center: Start out going NORTH on FAIRGROUNDS ENTRANCE toward US-50 W. Turn LEFT onto US-50 W. Turn RIGHT onto PITKIN AVE/I-70 BL E/US-6 BL E. Continue to follow I-70 BL E/US-6 BL E. Turn LEFT onto N 28TH RD. Turn LEFT onto E NORTH AVE/US-6 W. End at 1660 North Ave Grand Junction, CO 81501-6422

ROUTES TO THE TRIAL

From I-70, Take the I-70-BL exit, EXIT 37, toward US-6/ CLIFTON/ GRAND JCT. Merge onto I-70 BL W. Turn LEFT onto 32 RD (1.2 miles). Stay STRAIGHT to go onto 32 RD/ CO-141 (5.1 mile). Turn SLIGHT RIGHT onto US-50 W (3.6 mile). Turn left at the stop light into the Fairgrounds. The parking lot is straight ahead and to the right

DIRECTIONS FROM HOTELS ON HORIZON DRIVE: Take Horizon Drive toward downtown. At the traffic circle by Safeway, turn south on 12th street. Travel about 3 miles to Ute Avenue (one way heading West). Turn right (West) on Ute Avenue. Turn left on 5th St. (Follow signs toward Hiway 50, to Delta, Montrose). 5th St. becomes Hiway 50. Follow Hiway 50 until you come to the Mesa County Fairgrounds on your right. Turn right at the stop light. The parking lot is straight ahead and to the right.

AT JUDGE'S OPTION, CLASSES WILL HAVE ADDITIONAL SPLIT WALK-THRU'S AND/OR RUNS OR COMBINED WALK-THRU'S IN THE FAST CLASSES. SPECIFIC INSTRUCTIONS WILL BE GIVEN DURING THE JUDGE'S BRIEFING.

A warm-up area, consisting of a regulation agility jump, shall be provided for all exhibitors.
